RE: Metro South Bay Service Council Selection Recommendation

The South Bay Service Council has been in existence since 2003 and has been extremely successful. The dedicated people on our council have worked with Metro staff to make changes in service to improve efficiency and coordination of transit services provided by the Metro.

Service Council terms are staggered with 3 of the 9 positions expiring June 30 every year. The 3 members whose terms are expiring this June are: Rolling Hills Estates Mayor John Addleman, Redondo Beach businessman Don Szerlip and Redondo Beach Resident Elaine Jeng who is a civil engineer as well and a resident of Manhattan Beach. All 3 incumbents have re-filed to be considered for another term. Also, 3 other applications were submitted prior to the deadline: Hermosa Beach Mayor Peter Tucker, Gardena Councilman Dan Medina and Torrance Resident Charles Michel Deemer. Their nomination information is included in the packet in alphabetical order.

The Steering Committee met to review the applications on two occasions – May 11 and May 19. The review was done twice since one of the applicants was inadvertently omitted from the initial review. After hearing statements from those candidates who were present as well as having the chair read the qualifications and statements from those not present, the Steering Committee makes the following recommendation.

RECOMMENDATION

The Steering Committee recommends that the following 3 nominees be recommended to the Metro Board for selection to serve for the next 3 years on the South Bay Service Council:

- Charles Michel Deemer
 - Torrance City Commissioner
- Dan Medina
 - Gardena City Councilman
- Don Szerlip
 - Redondo Beach businessman

MEMBERSHIP REQUIREMENTS

Members of the Councils may be elected officials and/or private citizens. The members of the Councils should reflect a broad spectrum of interests and geographic areas of the Service Council region. Metro has set a requirement that at least 50% of the Council members must be consumers of transit service. They are interpreting this broadly to

include not only transit users, but also businesses that have an employee transportation program, transit operator representatives, cities which have bus stops, etc. Members of

the Council must reside or work within the Service Council boundaries. Membership is not transferable or assignable and is for a 3 year staggered term. Service Councils can have up to 9 members and as few as 5 members.

SPECIFIC CONSIDERATIONS FOR THE SOUTH BAY SERVICE COUNCIL COMPOSITION

The SBCCOG Board of Directors has previously stated a strong preference that transit users or those familiar with the South Bay transit services be Service Council members and in no case shall elected officials represent a majority of the Board. Since other service councils have elected officials on their boards, the South Bay Service Council should include at least some elected officials in order to have the same ‘status’ before the Metro Board as the other service councils.

Some other factors that were previously discussed for inclusion are the participation of:

- Our municipal operators – Gardena, Torrance, Redondo Beach & L.A. City
- Our community operators – Carson, PV Transit, Lawndale, Municipal Area Express
- Community members (Metro South Bay Citizens’ Advisory Committee representatives? members from the Metro or municipal operators’ Passenger Advisory Committees?)
- Cities with the most transit riders – Inglewood, L.A. City
- Employers in the South Bay who have transportation programs
- A City Manager, the COG, etc.
- A city Public Works Director/Transportation staff
- A senior transit user
- A School District Transportation person

During the 1970's, I attended both El Camino College & Long Beach State traveling by bus. I've maintained the practice for all the years since then. So, I've seen first hand the evolution of transit service within Southern California. I've always been interested in local transportation and was quite pleased when the Blue Line service was resumed 25 years ago. It's been my belief that an adequately broad combination of trolley-lines and buses would be most useful in moving people around the region.

Over the past decade in Torrance, as a member of the public during the reconfiguration planning to the bus network in Torrance, I made several suggestions on service changes. Some of which turned out to be useful or more appropriate to the overall changes then being considered. Also, often

I was the only person making comments regarding the planning for the new

Torrance Transit Terminal planned for Crenshaw Blvd. when it was in front of the Torrance City Council. My main focus was on ease of getting in/out of the Terminal area safely.

Additionally, I attended in the various rounds of the study work regarding

the extension of the Green Line towards Redondo Beach and Torrance. So, I'm already, relatively speaking, up-to-date on its current planning progress.

I believe that my enthusiasm about transit and past studies of the old systems

(both bus & rail) history will provide an interested perspective when future systems changes in the area are considered by the Service Council. So, I'd be very pleased to be one of the 3 candidates chosen for this round by the Board.

Dan Medina was elected by the citizens of Gardena to serve as a member of the City Council in November 2008. He was elected to a second term in March 2011, elected again in March 2015 and is serving a third term. He served as Mayor Pro Tem for one year from March 2013 to March 2014.

Medina is a long-time resident of Gardena and a very familiar face in the community. Why do I want to become a member of the South Bay Service Council?

I'm a lifelong resident of the South Bay having been raised in Manhattan Beach and now living in the City of Hermosa for the past forty two year. I can remember when I could take the RDT busses to the Los Angeles Coliseum to watch the Dodgers play or go to Redondo for a doctor's appointment. Bus services and other transportation systems that will reduce the use automobiles is key to making the South Bay a leader Stainability. The bus route must reduce the walking distances to places of employment and connect to transit stations for the longer commute to larger employment areas such as downtown Los Angeles and the LAX employment centers.

Business need assistance in providing transportation systems that can not only provide employees with public transportation but also bend with the general public needs. Staging times of public transportation at pick demands will increase the use public transportation . Transportation stops need to be located within short walking or bicycling distances to places of employment and public needs.

Students need of better public transportation in order to get to school and return home safely and on time. Coordination with business, public and student needs will reduce the need to use the automobile and make the South Bay the leader of Sustainability for not only the environment but also quality of live.

I help negotiate with Caltrans to move forward with Pacific Coast Highway (PCH) and Aviation Mobility Improvement Plan. Caltrans prepared a Project Study report (PSR) and a Project Invitation Document (PID) for this project.
